

**SUMMARY ANNUAL REPORT FOR
BARNES GROUP INC. HEALTH AND WELFARE PLAN**

This is a summary of the annual report of the BARNES GROUP INC. HEALTH AND WELFARE PLAN (Employer Identification Number 06-0247840, Plan Number 518) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BARNES GROUP INC. has committed itself to pay certain Legal, Health, Prescription drug, Dental, Temporary disability, Flexible spending account, Wellness, Employee assistance program claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with VISION SERVICE PLAN, NATIONAL UNION FIRE INS. CO. OF PITTSBURGH, PA and THE GUARDIAN LIFE INSURANCE COMPANY OF AMERICA to pay certain Vision, Business travel accident, Life insurance, Long-term disability, Accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$1,100,456.
